

SENDING MONEY TO UTAH DEPARTMENT OF CORRECTIONS

To avoid processing delays, DO NOT MAIL DEPOSITS TO THE PRISON. Instead, send cashier's checks or money orders directly to our finance department at the address provided in the examples below.

Please remember the money order/cashier's checks must have the following information:

Deposits to **Prison** Account:

1. Deposit to Trust Account vs Applying to Debt Account:
 - a. **Trust Account (for spending):** Money order/cashier's check to be made out to the inmate's name and include the inmate number.
 - b. **Debt Account:** Money order/cashier's check to be made out to UDOC and include the inmate number.
2. Specify on the "for" line if you would like the funds applied to a specific debt, otherwise it will be deposited on the trust account, and the system will decide where it will go.
3. The sender's name and address must be included on the money order/cashier's check and match the envelope's return name and address.

**Please see the Prison example on page two.

Deposits to **AP&P** Account:

1. Make it payable to **UDOC - AP&P** and include the offender's name and number.
2. Specify on the "for" line if you would like to apply the funds to restitution debt, supervision fees, etc.
3. The sender's name and address must be included on the money order/cashier's check and match the envelope's return name and address.

***Please understand that the system for the AP&P account will decide where funds are applied to, based on location and priority.

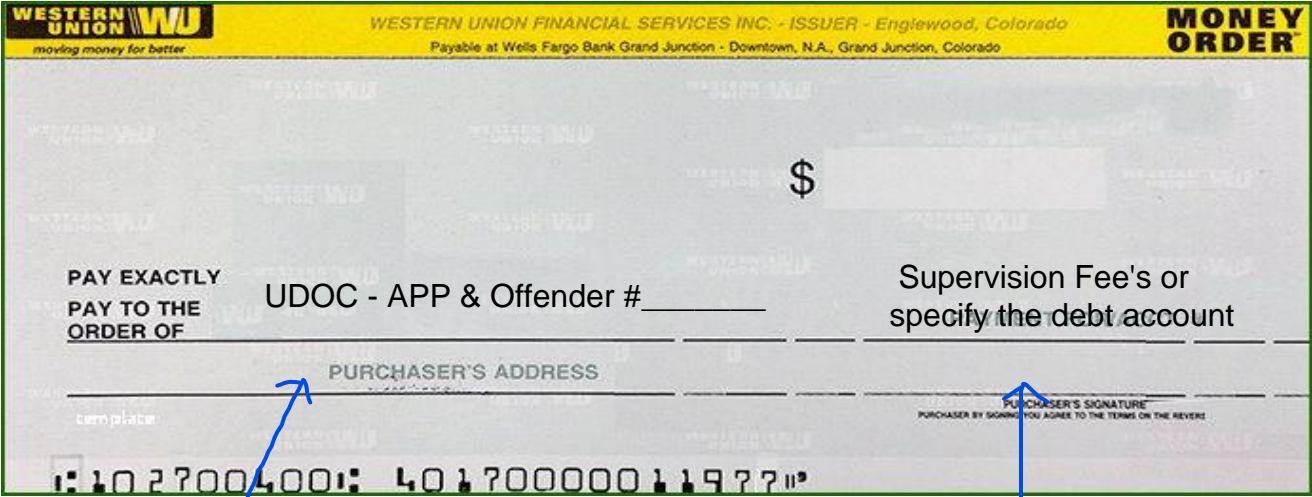
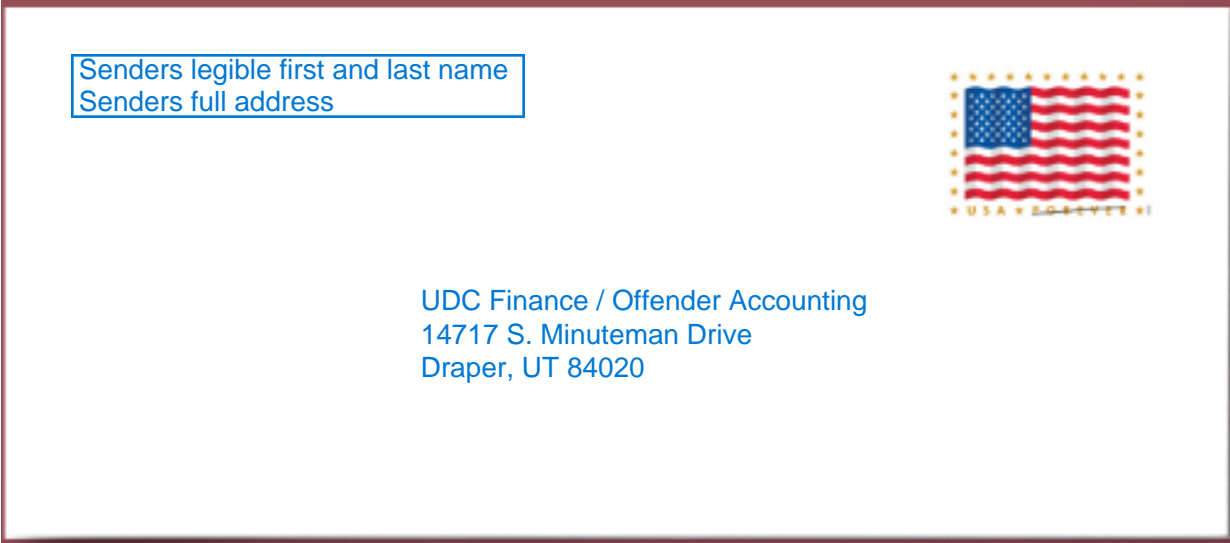
