

Probation Standard Conditions

Condition Title	Condition Description
Intro	I, __[Probationer Name]_____, agree to be directed and supervised by Agents of the Utah State DOC. I agree to abide by all conditions of probation as ordered by the Court and set forth in this agreement and consistent with the laws of Utah as defined.
RESIDENCE	I will live at the approved address listed with AP&P. I will not change, live, or stay at any other location without prior approval from AP&P. I will not reside on a Native American Indian reservation or in Indian Country without prior approval of AP&P.
VISITS	I will permit AP&P to visit my residence or other place where I am present, and conduct searches and seizures according to state law. I will not try to avoid or interfere with these visits including, but not limited to, refusing to answer the door, security systems, allowing aggressive animals on the property, etc.
ABSCONDING	I will not abscond from supervision. This includes leaving the jurisdiction of Utah and/or changing my residence in an effort to conceal my location from AP&P.
REPORTING A	I will report to AP&P within one business day of being sentenced to probation / released from jail, unless otherwise directed by the court/AP&P.
REPORTING B	During my supervision period, I will report as directed by AP&P.
REPORTING C	I will not leave the state of Utah, even briefly, or any other state to which I am released or transferred, without prior written permission from AP&P.
REPORTING D	I will update AP&P with all of my current contact information.
CONDUCT A	I will obey all federal, state and local laws and all court orders.
CONDUCT B	I will cooperate with the Court, DOC, and AP&P in furtherance of my supervision.

CONDUCT C	I will not associate with any person who is involved in criminal activity.
CONDUCT D	If I have contact with law enforcement, I will notify AP&P as soon as possible, but not later than 24 hours after the interaction.
CONDUCT E	I will not associate with convicted felons without prior approval of AP&P.
WEAPONS	I will not buy, own, use, have, or control any dangerous weapon including but not limited to a firearm or replica, explosives, ammunition as defined in UCA 53-5d-102, bows, arrows, or crossbows. I will not have these items in or on my property, person, or vehicle, or any property or vehicle I visit or am a passenger in.
SUBSTANCE USE/TESTING	I will not consume or possess illegal substances. I will take tests of breath, urine, blood, or hair when asked by AP&P.
SEARCHES A	I understand that while I am on probation, AP&P can search me, my things, vehicle, residence, or other property, including, but not limited to electronic devices under my control without a warrant at any time, day or night upon reasonable suspicion.
SEARCHES B	I also understand that any law enforcement officer can search me, my things, vehicle, residence, or other property under my control with permission of AP&P upon reasonable suspicion.
EMPLOYMENT	I will get and keep approved lawful verifiable employment, 30 hours a week minimum, unless otherwise directed by AP&P. I will notify AP&P within 72 hours of any change in my employment.
SUPERVISION FEES	I agree to pay a supervision fee of \$30 per month unless granted a waiver by the Department of Corrections under the provisions of Utah Statute 64-13-21. I understand that failure to pay may be subject to collections and State withholding tax.
DNA	I will comply with Utah Code Annotated Section 53-10-403-406 by submitting an adequate DNA specimen, and, unless determination is made that there is no ability to pay, pay the required fee specified by statute.

CURFEW	I will follow the curfew set by AP&P in accordance with policy and the standards of supervision.
COMPLIANCE	I will be cooperative, compliant, and truthful in all dealings with AP&P. I will comply with my Case Action Plan.
CONTACT	Unless otherwise approved by the court, I will not have contact with any victim or co-defendant of my current commitment or supervised offenses, without the prior approval of AP&P. I will follow a more specific special and/or group no contact condition if I have one.
TREATMENT RELEASE OF INFORMATION	I will sign a release of information at any treatment program I attend so they can share information with AP&P.
EARNED COMPLIANCE	I understand that if I fully comply with my probation and Case Action Plan, the court may terminate my probation earlier than the original term, in its discretion or pursuant to AP&P's earned compliance program as established in Utah Code §64-13-21(7)
RESPONSES / INCENTIVES	My supervision will include the standards and requirements of the responses and incentives created by the Utah Sentencing Commission pursuant to Utah Code §63M-7-404.
EXTRADITION WAIVER	I hereby waive extradition to the State of Utah from any jurisdiction in or outside the United States of America where I may be found and I will not contest any effort by any jurisdiction to return me to the State of Utah. ²
GRIEVANCE NOTIFICATION	A grievance procedure exists, which you may utilize if you feel your rights have been compromised or you have been treated in an unfair or discriminatory manner. Your supervising agent and/or supervisor will provide the necessary form at your request.
