

SENDING MONEY TO UTAH DEPARTMENT OF CORRECTIONS

You may send a money transfer or cashier's check directly to our finance building to the address listed below. DO NOT MAIL TO THE PRISON, it may be delayed or rerouted to Pigeonly and delayed further.

Please remember the money order/cashier's checks must have the following information:

Deposits to **Prison** Account:

1. Money order/cashier's check to be made out to the inmate's name and include the inmate number.
2. Specify on the "for" line if you would like the funds applied to a specific debt, otherwise it will be deposited on the trust account and the system will decide where it will go.
3. The sender's name and address must be included on the money order/cashier's check and match the envelope's return name and address.

**Please see the following page for an example.

Deposits to **AP&P** Account:

1. Make it payable to UDC or AP&P and include the offender's name and number.
2. Specify on the "for" line if you would like to apply the funds to restitution debt, supervision fees, etc.
3. The sender's name and address must be included on the money order/cashier's check and match the envelope's return name and address.

***Please understand that the system for the AP&P account will decide where funds are applied to, based on location and priority.
